# **PUBLIC COMMENT:**

Josh Loyd asked when he would get an update on the Fire Department, and said there were rumors that the Town of Beloit would be experiencing staffing issues. Mr. Loyd mentioned an inventory list of items that he requested under the Freedom of Information Act, and named items that were not on the list. Mr. Loyd questioned why the items were not on the list.

## Mayor-Tom Fitzgerald

#### **UNFINISHED BUSINESS:**

- 1. Discussion and/or Motion Items:
  - Commissioner Adleman made a motion to approve Ordinance 2836 Amending Chapter 62, Offenses and Miscellaneous Provisions, Article III, Offenses against the Public Peace and Safety, Prohibiting the Possession, Transfer, or Sale of Unregulated Food and Beverage Products Infused with Cannabis or Containing any Amount of Tetrahydrocannabinol Acetate Ester (THCO). Commissioner Prentice second the motion. Attorney Sosnowski reviewed the ordinance that would prohibit the sale of Delta 8 and Delta 9 products in any location other than cannabis stores that have been state approved. An ordinance violation for possession or offering for sale of the products would go through the City's Code Hearing process imposing a fine or the revocation or suspension of the business license. Mayor Fitzgerald expressed concern over the products being unregulated by the state. Attorney Sosnowski said the City has received concerns from residents with the products being sold near schools. Commissioner Adleman voiced concern with there being no age limits to buy the products similar cigarette product regulations. Commissioner Hedrington asked if the products are illegal. Attorney Sosnowski said they were not illegal. Administrator Hoppes said she spoke with Commissioner Morse, who said he is strongly opposed to the product without regulations. Commissioner Prentice asked if the goal is to place regulations on the product before it becomes an issue. Mayor Fitzgerald said there are other municipalities where the products have been prohibited. Mayor Fitzgerald said the products have too many unknowns. Roll call vote showed 2 ayes, 1 abstain by Commissioner Hedrington, 1 nay by Commissioner Prentice, and 1 absent by Commissioner Morse. The item failed.
  - Commissioner Adleman made a motion to approve Ordinance 2848 Amending Chapter 18, Businesses, by adding Article XII, Residential Rental Property Regulation. Commissioner Hedrington second the motion. Council discussed two amendments made to the ordinance as requested. Crime Free Housing was removed, and the age requirement was changed from 21 to 18. Neely Erickson was present on behalf of the Realtors Association. Ms. Erickson asked if there could be a reference added for the appeals process and expressed concerns regarding the requirement for all property owners to register. Ms. Erickson said the ordinance is still overly broad, targets all rental properties without focusing on nuisance properties, and will make the process burdensome for property owners of rental owners. Council briefly discussed an ordinance from Woodstock provided by Attorney Sosnowski. Commissioner Prentice said he believes the ordinance is overreaching. Commissioner Adleman would like to look at the Woodstock ordinance to consider revisions closer to Woodstock's ordinance. Commissioner Hedrington made a motion to layover Ordinance 2848 so that Commissioner Morse could weigh in. Commissioner Adleman second the motion. Voice vote carried the motion.
  - Chapter 10 Animals, Article II Dogs and Cats. Commissioner Adleman second the motion. Mayor Fitzgerald said the ordinance is simply omitting the requirement to have cats on leashes, which will allow for trapping and neutering from other animal organizations. Resident, Sarah McLain said she is the owner of Beloit TNR, and has been trapping and neutering cats under her 501(c)(3) non-profit business. Ms. McLain spoke about the efforts that have been made by her business, adding she would like to have a working relationship with the City. Council discussed the issue with feral cats reproducing. Commissioner Hedrington said part of the issue is residents that continue to feed feral cats. Commissioner Hedrington said he had a dog, and he did not let his dog run freely defecating in neighbors yards; however, neighbors in his neighborhood feed the feral cats and there is nothing done with the issue. Mayor Fitzgerald said if the leash law is removed the organization, Cares for Pets would be able to come in to work with the City regarding the feral cat issue.

Commissioner Adleman made a motion to lay the item over to the next meeting so that Commissioner Morse could weigh in on the conversation. Commissioner Prentice second the motion. Voice vote carried the motion.

- g. Commissioner Adleman made a motion to approve Ordinance <u>2856</u> Amending Appendix A 2022 City of South Beloit Ordinance Fines. Commissioner Prentice second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Morse
- h. Commissioner Adleman made a motion to approve Resolution <u>6627</u> Approving a Hotel/Motel Grant Application for the South Beloit Historical Society in the amount of \$8,500.00. Commissioner Prentice second the motion. Roll call vote showed 4 ayes and 1 absent by Commissioner Morse.
- i. Commissioner Adleman made a motion to approve Resolution <u>6628</u> Re-appointing members to the Library Board as follows:
